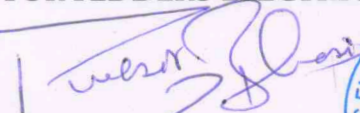

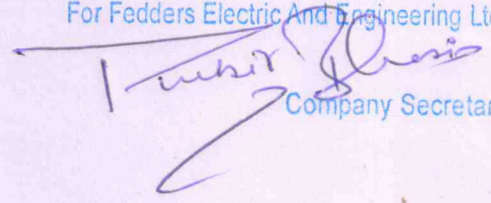

However the company has appointed a new Auditor vide meeting held on 10.08.2018, subject to the approval of the shareholders. The said appointment shall also be approved by the company at a General Meeting to be convened within 3 months of the recommendation of the Board.

Keeping in view, the aforesaid circumstances due to which company cannot hold its Annual General Meeting on time, extension 3 months 0 days is considered.

ORDER

Under the power vested in the undersigned by virtue of section 96(1) read with second proviso attached thereto extension of 3 months 0 days is hereby granted. However, the company is hereby advised to be careful in future in compliance of the provisions of the Companies Act, 2013.
