We write in furtherance to our letter dated 30th December, 2016 and 13th January, 2017 filed with the Stock Exchange(s). In this regard, we hereby reiterate that the Company had, pursuant to the requisite approvals and subsequent upon receipt of 25% of the issue price from the Promoters' and Promoters' Group, allotted 50,00,000 warrants convertible into equivalent number of equity shares on preferential basis to its Promoters and Promoters' Group on 3rd August, 2015 at the issue price of Rs. 75 per warrant.
